# **Important Updates for 2024**

## **Appointment Policy**

We are currently accepting Tax Appointments starting February 3<sup>rd</sup>. Schedule your appointment early to secure your spot. Please be fully prepared with all necessary documents at the time of your appointment or feel free to drop off or <u>upload</u> your documents early. We continue to accept new clients only until capacity is reached. Current clients receive priority.

## 1099 Filing – for Subcontractors, Service Providers and Rent Paid

- Deadline: January 31, 2024. Late Penalties range from \$60-\$660 per form
- Contact us by **January 17th** for assistance with issuing and filing.

## 2024 Mileage Reimbursement Rates - Mileage Log

The IRS sets mileage reimbursement rates annually to account for inflation and fuel costs. For 2024 mileage rates are:

- 67 cents per mile for business use.
- 14 cents per mile for charitable purposes.
- 21 cents per mile for medical or moving expenses (for active-duty military).

## **BOI Reporting - Corporate Transparency Act**

Enforcement of the CTA has been temporarily blocked by a federal court. We'll provide updates as the situation evolves.

### Virtual Currency – 1099-DA

• Reporting is mandatory for digital asset transactions. Be prepared with detailed transaction logs and 1099-DA forms you receive.

#### **Retirement Accounts**

- Contribution Deadline for 2024: April 15, 2025.
- 2024 Limits: \$7,000 (\$8,000 if over 50).
- RMDs begin at age 73.

## Adjusted Income Tax Brackets

The IRS has updated the tax brackets for inflation: The following shows tax rates based on taxable income - Single (S), Married Filing Jointly (MFJ) and Head of Household (HOH)

- **10%:** Up to \$11,600 (S) / \$23,200 (MFJ) / \$16,550 (HOH)
- 12%: \$11,601-\$47,150 (S) / \$23,201-\$94,300 (MFJ) / \$16,551-\$63,100 (HOH)
- 22%: \$47,151-\$100,525 (S) / \$94,301-\$201,050 (MFJ) / \$63,101-\$100,500 (HOH)
- **24%**: \$100,526–\$191,950 (S) / \$201,051–\$383,900 (MFJ) / \$100,501–\$191,950 (HOH)
- **32%**: \$191,951–\$243,725 (S) / \$383,901–\$487,450 (MFJ) / \$191,951–\$243,700 (HOH)
- **35%:** \$243,726–\$609,350 (S) / \$487,451–\$731,200 (MFJ) / \$243,701–\$609,350 (HOH)
- **37%:** Over \$609,351 (S) / Over \$731,201 (MFJ) / Over \$609,351 (HOH)

### **Standard Deduction Amounts**

• Single/Married Filing Separately: \$14,600

Married Filing Jointly: \$29,200Head of Household: \$21,900

#### Child Tax Credit

• Up to \$2,000 per qualifying child under 17.

• Refundable portion: Up to \$1,700.

#### 2024 Education Tax Credits

Education-related tax credits can significantly reduce your tax if you or your dependents are enrolled in college.

## American Opportunity Tax Credit (AOTC):

- o Up to \$2,500 per eligible student. *Partially refundable*
- Available for the first four years of post-secondary education.
- Phases out for Modified Adjusted Gross Income (MAGI) above \$80,000 (single) or \$160,000 (married filing jointly).

## Lifetime Learning Credit (LLC):

- o Up to \$2,000 per tax return (not per student). Non-refundable
- Available for undergraduate, graduate, or professional courses.
- o Phases out for MAGI above \$80,000 (single) or \$160,000 (married filing jointly).

## **Kiddie Tax Updates for 2024**

The **Kiddie Tax** applies to unearned income for children under 18 (or under 24 if a full-time student).

- Unearned income above \$2,600 will be taxed at the parents' marginal tax rate.
- Earned income (e.g., wages from a part-time job) is taxed at the child's tax rate.
- Applies to income from sources such as investments, dividends, or capital gains.

To avoid higher taxes on unearned income, consider tax-advantaged savings accounts like 529 plans.

## Health Savings Accounts (HSAs)

#### **Contribution Limits:**

Self-Only Coverage: \$4,150Family Coverage: \$8,300

• Additional \$1,000 for individuals 55 or older.

**1099-SA form** required for all HSA distributions (Medical Expenses, etc.)

### Affordable Care Act (ACA) Reminders for 2024

If you purchased health insurance through the Marketplace, you must include Form 1095-A when filing your taxes.

- Form 1095-A: This document confirms your health insurance details and reconciles any Premium Tax Credits. Access it through your Marketplace account.
- Mandatory for E-File: Tax returns will be rejected electronically if Form 1095-A is missing.
- Individual Mandate Penalty: The federal penalty for not having health insurance remains \$0, but some states may have their own penalties.

## Clean Energy & Electric Vehicle Credits

If you have bought or are planning to buy an electric vehicle let you tax prepare know.

- Home Improvements: 30% credit up to \$1,200 (\$2,000 for heat pumps).
- Solar Installations: 30% credit with no annual or lifetime limits.
- **Electric Vehicles**: Up to \$7,500 credit, subject to income limits.

#### 2024 Gift Tax Exclusions and Rates

The federal gift tax rules for 2024 allow for significant tax-free giving, but understanding the limits is key to avoiding unnecessary tax burdens:

- **Annual Exclusion:** You can gift up to \$18,000 per recipient without incurring gift tax or affecting your lifetime exemption.
- Married Couples: Spouses can combine their exclusions, giving up to \$36,000 per recipient tax-free.

## Foreign Bank Account Reporting (FBAR) Requirements

If you have foreign financial accounts, it's crucial to stay compliant with U.S. tax laws. Please ensure you have accurate records of all foreign accounts. Here's what you need to know for 2024:

- Who Needs to File: U.S. citizens, residents, and entities with a total value exceeding \$10,000 across foreign financial accounts at any time during the year must file FinCEN Form 114 (FBAR).
- Key Deadlines:
  - o FBAR Filing: Due April 15, 2025, with an automatic extension to October 15, 2025, if needed.
  - Penalty for Non-Compliance: Failure to report can result in penalties of up to \$10,000 per violation, or higher for willful non-compliance.
- **FATCA Reporting:** If you meet certain thresholds, you may also need to file **Form 8938** with your tax return under the Foreign Account Tax Compliance Act (FATCA).
